

8. MATTERS ARISING (For Information Only)

- a. **Signs on the roadside:** (See Minutes FC 04/2014 Item 21 para 2) The Clerk advised that signs are not allowed on the Highway, however, providing they are not causing a hazard or visibility issues Cambs Highways tend to let them be. It is costly to send a crew out to collect them and then they have to be stored in case the owners wish to claim them back. The Enforcement Officer will have a purge from time to time but it is time consuming. If parishioners wish to remove them that is acceptable as they are illegal anyway.
- b. **Grass at Linden Way entrance:** (See Minutes FC 04/2014 Item 21 para 4) The grass area is the responsibility of Cambs Highways. It had been cut on 15th April and will receive two more cuts during the season.
- c. **Response from Planning re additional comment for temporary wind mast:** (See Minutes FC 04/2104 Item13) The Clerk had returned the additional comments but the Planning Officer had advised that additional conditions could not be applied to the application as it has now been determined.

The Clerk will enquire if there are plans for any County lights to be replaced in the village.
