

11. MATTERS ARISING (For Information Only)

- a. **Street Lighting:** (See Minutes FC 04/2015 Item 2a) Some of the problems have been resolved but others are outstanding. Balfour Beatty will be back in the village on 15th June to complete the replacement works and it is hoped the other issues will also be resolved at that time. The Council will continue to chase up on the outstanding items.
- b. **AmeyCespa guided tour:** (See Minutes FC 04/2015 Item 16 para 4) The Clerk confirmed that the date for the tour would be Thursday 21st May at 10.00am.
- c. **Planning notices:** (See Minutes FC 04/2015 Item 16 para 1) The Planning Department had replied regarding planning notices being left on telegraph poles and a reminder will be given to the team to look out for and remove old notices but there are no resources to go back to every site and remove expired notices. There would be no objection to councillors or members of the public removing the notices provided the period for comments has expired.
- d. **Regulation 123 List Projects:** (See Minutes FC 04/2014 Item 9O) The Clerk advised that it is now appreciated that stakeholders needed more clarity and information to enable more detailed bids to be submitted and to assist with future submissions a training workshop will be held in the summer. The Clerk will obtain details of the workshop and when it will be held. The expressions of interest were considered and scored by the Joint East Cambs and County Council Member and Officer Steering Group for Planning and Transport and in order for a bid to be recommended to the Full District Council for approval a score of 50% or more was required. The Full Council must agree the inclusion of a project on the R123 List following a recommendation from the Steering Group. A draft Transport Strategy for East Cambs is being produced and projects could be included in this then resubmitted for consideration for inclusion on the R123 List.
- e. **Anemometer Mast:** (See Minutes FC 04 2015 Item 16 para 3) The planning conditions on the mast have now been discharged.
