8. INFORMATION FROM DISTRICT & COUNTY COUNCILLORS

Cllr Cheetham reported that a Homelessness Strategy for 2015 – 18 has been approved. The Care & Repair Services will be retained in-house and a capital loan pot of £20,000 will be available for residents who cannot access funding. The Local Authority Trading Company Committee has approved a Forward Agenda Plan and this will be presented to the Full Council in January 2016. The Asset Development Committee has agreed bus shelter improvements in Ely and also approved the terms of reference for the LATC. The Committee intends to take legal recourse to recover car parking spaces at Poets House in Ely. The Angel Drove Car Park decking proposals have been withdrawn and an alternative ground level solution is being sought. The Electoral Roll follow up is almost complete and showing an increase in numbers registering. A new website has been launched called Enterprise East Cambridgeshire www.enterpriseeastcambs.co.uk. The website has been established to encourage, support and deliver business initiatives that increase sustainable economic growth and inward investment. The Tree Preservation Order on seven Oak trees in Berry Fen has been confirmed.

Cllr Hunt had sent papers relating to a planning application at Dimmock's Cote Quarry and the Clerk confirmed that a response had already been sent from Haddenham highlighting concerns regarding increased HCV traffic in the village and urging that an agreement should be put in place for those vehicles to only use the main roads and not cut through villages.
