- F. Recreation:** The timers are working well and the immersion heaters now only come on at weekends.

13. PLANNING APPLICATION 13/01071/VAR LAND NORTH OF 9 – 11 NORTHUMBRIA CLOSE, HADDENHAM

An application had been received for the variation of Condition 2 (Approved Drawings) of Appeal Decision APP/V0510/A/13/2192733 dated 02.10.13. The application seeks to amend the condition set out in the appeal decision to rectify a mistake made by the Planning Inspector when granting the appeal as he referred to two incorrect drawings (09 & 40) and to ensure that the most up to date plan is used. Cllr Fairchild proposed and Cllr P Wilson seconded that there were no objections. Motion carried unanimously.

14. FUNDING FOR TOWN & PARISH COUNCILS

The Clerk reported that the amount of Parish Additional Funding passed on to parish councils from the District Council would reduce over the next three years by 25% year on year. The District Council's funding from the Government (Revenue Support Grant) is set to fall over the next few years and the funding for parish and town councils has been "rolled" into the RSG. The actual amount of town and parish funding from the Government is not yet known but the District Council has had to make the assumption that it will also reduce in line with the overall RSG.
