

**MINUTES OF THE MEETING OF THE PLANNING COMMITTEE OF HADDENHAM PARISH COUNCIL held on Tuesday 21<sup>st</sup> June 2016 at 7.00pm at Haddenham Library, Station Road, Haddenham, Cambs.**

1. **APOLOGIES FOR ABSENCE** were received from Cllr Tindall – work commitment and Cllr Parr – illness.

2. **DECLARATIONS OF INTEREST**

There were no declarations of interest.

3. **MINUTES OF THE LAST MEETING** having been circulated to all members were taken as read. Cllr Goddard proposed and Cllr Smith seconded that the minutes should be signed as a true record of the meeting. Motion carried unanimously.

5. **PUBLIC PARTICIPATION**

The applicants and adjoining neighbours of planning application 16/00663/FUL were in attendance and it was agreed they would be allowed to speak whilst the plan was being considered.

6. **PLANNING**

**16/00663/FUL 14A Station Road, Haddenham including amendment:** Demolition of existing property and erection of 2No detached residential dwellings including change of use to amenity residential gardens. The amendment involves an additional ground floor window within Plot 4 and amendments to the siting of the rain water down pipes. Cllr G Wilson proposed and Cllr Goddard seconded that there were no concerns. Motion carried unanimously.

**16/00741/FUL 7 New Road, Haddenham:** Rear extension, garage and front porch. Cllr Smith proposed and Cllr Ray seconded that there were no concerns. Motion carried unanimously.

**16/00691/CLP Former Grain Store, Hinton Hall Lane, Haddenham:** Dismantling and removal of the steel frame lean-to and the fan housing. The remaining concrete portal frame building to be converted to a single storey residential property. Plans had not been received therefore this item was not discussed.

**16/00662/FUL 2 & 3 School Lane, Aldreth:** Replacement dwelling with attached garage and associated works. Cllr Ray proposed and Cllr Smith seconded that there were no concerns. Motion carried unanimously

The Assistant Clerk informed the committee that planning permission was granted subject to conditions for the proposed extension to quarry at Dimmocks Cote Quarry, Stretham Road, Wicken E/3008/14/CM. The Assistant Clerk will obtain a copy of the conditions applied.
